

C-WAGS League

Heavenly Days will be hosting a C-WAGS Rally League beginning March 16, 2012, and continuing each Friday for 6 weeks. On the seventh week, we will all get together for a pot-luck dinner to celebrate awards and our great dogs.

The league will be limited to 25 dogs. Each night we will have one Starter rally course and one Zoom 1 rally course. Your dog can be entered in one or both leagues. All courses will be designed and judged by a C-WAGS judge under current C-WAGS rules. Therefore, all qualifying scores will count towards C-WAGS rally titles!

In order to keep expenses down and provide better prizes, there will be no placement ribbons each week. There will, however, be qualifying ribbons each week and new title ribbons and ACE ribbons. At the end of the six-week league, we will crown a Starters League Champion and a Zoom 1 League Champion based on cumulative scores. There will also be a number of non-score related awards given.

Cost of league participation is \$90.00 (each league, Starter League or Zoom League). If you want to reserve a spot in either the Starter or Zoom 1 league, you will need to pay a deposit of \$50 no later than March 1, 2012. If you find that you cannot participate in the league, your deposit will be refunded *if* I am able to fill your spot in the league.

C-WAGS Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS Obedience & Rally rules and regulations including but not limited to the following rules regarding entry:

- ♦ All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
- ♦ All judges and trial hosts are expected to show respect to all exhibitors.
- ♦ This trial is open to all dogs registered with C-WAGS.
- ♦ Trial Hosts may elect to accept FOR EXHIBITION ONLY entries of non-registered dogs.
- ♦ Teams may be entered in multiple levels/classes at the same trial.
- ♦ Dogs must be shown by a member of the owner's immediate family.
- ♦ Collars: The dog must wear a flat type collar (buckle, snap or proper fit martingale) and/or body harness in the ring. Electronic training collars are not allowed on the show grounds.
- ♦ Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge
- ♦ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.

In addition,

- ♦ The organizing committee may refuse any entry for any reason.
- ♦ THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- ♦ Refunds will be made for females in season upon written request accompanied by a statement from the exhibitor's veterinarian.
- ♦ Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made by money order within 7 days of notice to exhibitor of returned check. Any fees not received within 7 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible.
- ♦ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
- ♦ Dogs must be on leash while on show grounds unless being shown.

You must register your dog with C-WAGS in order to compete and receive credit in a C-WAGS sanctioned event. Please complete a separate registration for each dog you are registering. A registration number will be emailed to you. If you do not have an email address, it will be mailed. Please allow 2 weeks for processing registrations that include an email address, 3-4 weeks for regular mail.

CWAGS League play:

League will consist of 6 mini-trials held one weeknight a week for six consecutive weeks (subject to postponement due to Michigan weather). There will be two leagues – one for Starter rally and one for Zoom 1 rally. Teams may be entered in one or both leagues.

Each night, teams will compete in Starter and/or Zoom 1 rally. All courses will be designed and judged by approved C-WAG' judges and all scores will count towards titles. Teams will be able to move from the A to the B class during the league upon completion of a title.

Each trial will also be open to non-league competitors, subject to a total run limit of 35 runs per night. (League participants may also enter non-league runs if available.) All dogs must be registered with CWAGS to participate.

League competitors will compete for prizes including: Starter Champion (The lowest score will be dropped and the remaining 5 scores averaged. Any NQ score that is not dropped will be treated as a score of 65 for purposes of the average.)

Zoom 1 Champion (computed the same as starters)

Perfect Performance (qualifying scores in all 6 runs in starters or advanced)

Qualifying ribbons and placement ribbons will be awarded to all qualifiers. New title and ACE ribbons will also be awarded upon completion of a title. Additional awards may be granted at the discretion of the host club.

League cost: \$90 per team

Individual runs: \$20 each
